How to correctly fill out the "Antrag auf Vergabe einer steuerlichen Identifikationsnummer für nicht meldepflichtige Personen durch das Finanzamt"

(Application for the issuance of a tax identification number by the tax office for persons who are not required to report their tax status)

- 1. Put a check mark at "sonstiger Grund" (other reason)
- 2. Write in gap next to it as explanation "Kurzfristige Beschäftigung, Praktikum" (short-term employment, internship)
- 3. StNr Arbeitgeber (tax number employer) = DE 118714904
- 4. Bei Firma (at company): Deutsches Elektronen-Synchrotron (DESY)
- 5. Name = Last name as indicated in the passport
- 6. Vorname = First name as indicated in the passport
- 7. Anschrift im Ausland = Address in your home country (street, house number, ZIP-code, site, state)
- 8. Geburtsdatum = Date of birth (day, month, year)
- 9. Geburtort = Place of birth
- 10. Geburtsstaat = Birth country
- 11. Geburtsname = Birth name
- 12. Derzeitiger Aufenthalt in Deutschland = Current residence in Germany put a check mark at yes or no
- 13. Anschrift in Deutschland = address in Germany (street, house number, ZIP-code, site) (Since you are staying in the guest houses the address is also the same as in point 16)
- 14. Voraussichtliche Aufenthaltsdauer = expected length of stay from / to (22.07.2025 11.09.2025)
- 15. Datenschutzerklärung = privacy policy

- 20. Vorzulegende Unterlagen in Kopie = documents to be submitted in copy
